**COLAs.** As announced in October, there will be a 2.8 percent Cost of Living Adjustment (COLA) for Civil Service Retirement System (CSRS) annuities and Social Security benefits in 2019, but only a 2 percent COLA for Federal Employees Retirement System (FERS) retirees.

**PROMISING NEW RESEARCH TO BEGIN  
HUMAN TRIALS IN 2019**

According to recent publications, pharmaceutical remedies have failed in 99% of trials in Alzheimer's disease. Many companies have stopped making and testing new drugs to cure the fatal brain disease. As I reported in my presentation for National Alzheimer's Month in November 2018, research is concentrating on methods of treatment other than drugs.

One method which has worked in animal testing is the use of ultrasound to bombard the signature toxic amyloid proteins of Alzheimer's disease which invade the brain and lead to dementia and death. Researchers discovered that ultrasound clears the amyloid proteins from the brain in animals and testing on humans is slated to begin in late 2019.\*

Reduce your NARFE membership cost in 2019. NARFE National offers a membership dues reduction for retiree members who select dues withholding. How much? Presently annual national plus chapter dues total \$54 per year if paid annually. Select dues withhold, pay no money with your membership or renewal application, and \$4 will be withheld from your monthly benefit payment. That results in an annual cost of \$48, an annual savings of \$6, and a time saving for you in that renewal is automatic. No need for NARFE to send renewal reminders requiring your response every year. You may also have dues withheld for your member spouse. See me for more information and the required form.

Forms and information may also be obtained from the National web site. Enter "Dues Withholding" in the search box, select the form and download the resulting file. The brochure file can be opened, read and also downloaded.

NARFE also offers a lifetime national membership. A onetime payment depending on your age eliminates the need for annual national dues payment. Annual payment is required for Chapter dues. ### *Service Officer's Corner*

## **Happy New Year to Everyone!**

I thought I would take this opportunity to talk a little about the new changes coming down the pike for the Thrift Savings Plan (TSP). As you may recall, the TSP Modernization Act was passed and is expected to be fully implemented by mid-September 2019.

Under the new system, participants will no longer be forced to make a full withdrawal election—a choice between setting up annuity payments, taking a partial lump sum withdrawal, or a full lump sum payment—when they reach 70 and a half years old. People on installment payments can tell TSP that they want to stop taking installments for a while if desired.

TSP is working on three new forms to help participants make use of the new flexibilities, including one that allows participants to change the amount and frequency of their annuity payments at any time. You can change your monthly installment payments currently only once a year during a specific timeframe, but, in the future, you can choose between monthly, quarterly and annual installment payments, and changes can be made to that at any time during the year.

TSP officials said they plan not only to provide new flexibilities to participants, but make it easier to make use of those flexibilities. TSP will roll out four new “wizards” on the TSP website to help federal employees and retirees go through the various new processes. The “wizards” will tell you what’s in your account and will ask if you want to take withdrawals out of your Roth distribution or your traditional account. The “wizards” will understand what you have, so the “wizards” can suggest what distribution you can take – they will take you from start to finish in your withdrawal process.

The first phase of implementation, focused on installment payment maintenance and removal of the withdrawal selection deadline, is slated to go into testing shortly. The public rollout of the new features is slated to occur on September 15th, although TSP officials will begin communicating with participants about the coming changes as soon as February of this year.
